#### **User Guide: New Participation Report**

#### **Understanding the Structure and Format of the New Participation Report**

- ➤ The new report is presented on a financial statement basis.
- > Change in Premium Deficiency / (DPAC) is now included in the Operating Results calculation. On the old format, it was shown as a memo item.
- > Pre-Insurance Reports line has been removed; all previously stated amounts in the old format are now combined with Driver Record Abstracts.
- > Net Operating Results in the old format is now labeled as Funds held by FA/ (Members). The calculation remains the same: Operating Results less Distributed to Member.
- The Operating Results for the Current Month, for Fiscal Year to Date and for All Years to Date are each shown on separate pages, broken down by Private Passenger, Non Private Passenger, and Combined and split by accident years for each jurisdiction.
- > Balance Sheet figures are now available by accident year to accommodate regulatory and financial statement requirements. See pages 3, 7, 11, 15, 19 & 23. The 2 month projection figures are provided on page 26.
- > Memo items are provided by accident year as additional information for your actuaries, accountants, analysts, and management. See pages 4, 8, 12, 16, 20 & 24 for information on the following:
  - Future Cost on Unearned Premium
  - Undiscounted Premium Deficiency/(DPAC)
  - Undiscounted Future cost on Unearned
  - PFAD Included IBNR Provision
  - Undiscounted IBNR Provision
  - Undiscounted Retro Claims Expense

To assist readers in understanding the new report layout, the following table sets out a more detailed breakdown of the type of information provided by province for each page and shows whether each income statement item is added or subtracted to calculate the "Operating Result".
